Ready, Set, Go Program OFFICIAL RULES

NO PURCHASE NECESSARY TO PARTICIPATE OR WIN.

ELIGIBILITY: Open only to legal U.S. residents who are 18 years of age or older and residing in the 50 United States (includes District of Columbia). Employees of the American Automobile Association, Inc. ("Sponsor" or "AAA"), AAA Clubs, Homestead-Miami Speedway, LLC and their respective affiliates, subsidiaries, and parent companies, and employees of any promotion and other vendor agencies involved in this Sweepstakes, and their immediate family members and/or those living in the same household, are not eligible. THIRD (3rd) PLACE PRIZE awards which include: AAA Motorsports Merchandise Package including AAA #6 Official T-Shirt and AAA Racing Hat. Third Place prizes will be awarded to the Preferred Service Provider driver from each participating AAA club that receives the third highest point total (for every ERS call that is dispatched to a PSP driver as a tow, but resolved with a go solution, that driver receives **10 points**).

Total value of Grand Prizes (3) to be awarded is \$12,300 depending on travel expenses and \$267 for First, Second, Third prizes combined per participating club.

To become eligible for prize, the potential Grand prize winner must complete, sign, and return an affidavit of eligibility, mutually acceptable liability release, and publicity release within ten (10) calendar days of receipt of the notice, or the prize will be forfeited in its entirety and an alternate winner will be selected, time permitting. Failure of the PSP driver winners to respond within the ten (10) day period will forfeit the prize and the new prize winners will be drawn and notified, time permitting.
